Seniors Continue to Fight for a Fair State Budget

IARA members continue to mobilize across the state to call on Governor Rauner and the Illinois General Assembly to enact a fully funded state budget that protects critical state services for seniors, children, and families.



August 18th, IARA Members gather in Loves Park

On August 18th, IARA members

gathered in Loves Park to call on State Representative John Cabello to support critical senior services by voting "yes" on S.B. 1229. This legislation would have protected critical senior services by preventing a strike/ lockout of state employees in the event that they are unable to reach a contract settlement. Services that could be impacted by a disruption include providing aid and care to veterans, investigations into elder abuse, neglect and financial exploitation, and assistance through the Community Care Program, which keeps seniors out of nursing homes.

On Tuesday November 10th, IARA members, including Workers United Retirees, AFSCME Subchapter 163 and SOAR 31-9 joined with SEIU Healthcare Illinois and Indiana to call on legislators to restore cuts to childcare and protect vital senior services. Alliance members spoke with elected officials about the need to pass legislation protecting the Determination of Need Score (DON), as changes to this system could eliminate homecare services for thousands of seniors across the state.

This fall, IARA members participated in the Responsible Budget Coalition's

As IARA member Charlie Hogan told a December press event, "They need to put aside these nonbudget issues. They have to sit down and find the revenue. The money is there somewhere."

Illinois Retirees Call on Congress to Stand Up for Seniors, Prevent Giveaway to Drug Companies

On September 23rd, Congresswoman Jan Schakowsky joined with IARA members to call on Congress to stand up for consumers, taxpayers and seniors by opposing a special carve-out for drug companies. The pharmaceutical industry has attempted to secure a special exemption from the Inter Partes Review (IPR) process, which was put into place to allow for timely challenges to illegitimate patents. Illegitimate drug patents are one of the causes of rising drug prices. Special treatment for the pharmaceutical industry would cost taxpayers billions in higher prescription drug prices.

On September 15th, Congresswoman Tammy Duckworth was awarded IARA's 2015 Jerry Prete Award at our annual Senior Power Lunch. She has a lifetime score of 95% in the ARA's Congressional Voting Record. Congresswoman Duckworth has shown an unwavering commitment to expanding and strengthening retirement security programs, including Social Security, Medicare and the Affordable Care Act. Moving forward, we believe her strong leadership will greatly benefit seniors and working families in Illinois.

Granite City Passes Resolution Opposing TPP

On November 17, with leadership from IARA leader Jeff Rains, President of SOAR 11-96, the City Council of Granite City passed a resolution opposing the Trans Pacific Partnership trade deal. This agreement contains various provisions that could affect drug prices for seniors. If passed by Congress, these provisions would block patent reform and jeopardize the government's ability to lower drug programs like Medicare.
