This year, retirees across Illinois have been marching in the streets, lobbying in the halls of the Illinois State Capitol, and holding press events to highlight important issues for retirement security. We are holding our elected officials accountable to their communities and are committed to helping elect candidates who will protect and improve senior services and retirement security for all.

In January, we made our first endorsements in state elections, endorsing Juliana Stratton. In March, she defeated incumbent Ken Dunkin in the 5th House District primary race. Ms. Stratton will advocate tirelessly for the seniors in her community and across the state. In addition, the IARA endorsed Sam McCann, as he won his primary bid for reelection in the 50th Senate District. Senator McCann has been a true champion for working people. In January, IARA members joined with community partners, Representative Greg Harris and Congresswoman Jan Schakowsky to support House Bill 4351, the Community Care Protection Bill. The Governor has attempted to change the qualifications for this program and the Home Services Program. These changes would have resulted in 34,000 seniors and people with disabilities los-

As the on-going budget crisis continues, retirees from across the state are working to protect home care for seniors, which includes the Community Care Program (CCP). This successful program helps seniors stay in their homes and communities and it avoids premature and costly nursing homes. Governor Rauner's destructive agenda has included cuts to CCP.
