Alliance for Retired Americans Celebrates Anniversary of Social Security

Members of the Alliance for Retired Americans participated in two celebrations in August to mark the 79th anniversary of Social Security, America's most successful retirement security program.

On August 14th at the Laborers' Local 309 hall in Rock Island, over 40 members celebrated with Congresswoman Cheri Bustos. The Congresswoman was a leader in the successful defeat of the Chained CPI proposal, which lowers the Social Security cost-of-living-adjustment.

David DeBailie, an Alliance member, said "Congresswoman Bustos can be trusted to lead with our interests. Her views on keeping health care affordable and retirement secure are among the reasons that we stand with the Congresswoman."

At the Decatur Macon County Senior Center on August 15th, nearly 30 Alliance members gathered to support Ann Callis for election to the U.S. House for Illinois' 13th congressional district because of her strong positions on fighting Social Security and Medicare privatization.

This year, the Alliance looks forward to celebrating the 80th anniversary of Social Security and continuing to protect and strengthen this important program.

Alliance Members Rally in Champaign and Chicago on Medicare's Anniversary

On July 30th, area members of the Alliance celebrated the 49th anniversary of Medicare in front of Congressman Rodney Davis' Champaign office by rallying to call on him to preserve the Medicare guarantee. Congressman Davis voted in favor of privatizing Medicare.

Speakers shared their stories about why Medicare is important to them and delivered a birthday cake into Congressman Davis' office to ask him to strengthen, not cut, Medicare.

"Retirees in our area are struggling to get by, but they know how much worse things would be without Medicare. For nearly 50 years Medicare has given seniors the ability to see a doctor and fill a prescription," said David Spinner, an Alliance member.

On July 31st, Alliance members in Chicago protested outside of then gubernatorial candidate Bruce Rauner's office. Rauner avoided paying Medicare and Social Security taxes in 2010 and 2011, even though he reported a combined adjusted gross income of \$55 million. Members chanted, "Rauner's schemes are bad for retirement security and bad for Illinois' seniors."



Katie Jordan honored at Senior Power Lunch

At the annual Senior Power Lunch on September 9th in Des Plaines, Illinois Alliance Treasurer Katie Jordan, was honored with the 2014 Jerry Prete Award.

Joe Costigan, Director of the Illinois Department of Labor, presented the award to Katie Jordan, praising her as a trail blazer within the labor movement.

Katie Jordan was the first African American tailor at the Lytton's department store in Chicago in the 1960's. Her co-workers were inspired by her courage and elected her to be their shop steward of the Amalgamated Clothing Workers Union Local 5, making her the first African American shop steward in her work place. Later, she was the first woman elected to be an officer of the union.

Katie Jordan now serves as the President of the Workers United International Association of Retirees and serves on the SEIU Retirees National Advisory Council. She is also the President of the Chicago Chapter of the Coalition of Labor Union Women.

Other speakers at the Senior Power Lunch included the late Illinois Comptroller Judy Baar Topinka, Workers United Retiree Action Department Director Yadhira Alvarez, and Citizen Action/ Illinois Co-Director William McNary.
