
ations (CAG), an organization committed to building a nationwide movement to protect and expand care for seniors and people with disabilities.

#### Saving Medicaid, Medicare, and the ACA


In 2017, retirees mobilized across Illinois to fight back against the Trump/ Ryan plan to cut Medicaid, Medicare and the Affordable Care Act. Retiree leaders began by meeting with their Congressmen and Congresswomen to discuss concerns that an ACA repeal would have on seniors and their opposition to threatened cuts to Medicare and Medicaid. Throughout the year, members participated in vigils, rallies and press conferences in Belleville, Carbondale, Chicago, Rock Island and Springfield.

In a Letter to the Editor in the Decatur Herald-Review, IARA member David Spinner said, "These kinds of changes are not about improving health care or even saving money. Instead they will fund tax cuts for multinational corporations and the wealthiest Americans. Meanwhile, beneficiaries will pay significantly more out-of-pocket. The impacts will be devastating to all Americans".

After successfully defeating the effort to repeal the ACA, retirees continued to fight back against the recent tax bill. This bill provides tax cuts to wealthiest 1%, while threatening deep cuts to Medicare, Medicaid and

Social Security. Retirees mobilized in Barrington, Bloomington-Normal, Downers Grove, Champaign, Chicago, Springfield and West Chicago. Although the tax bill has passed, IARA Board Member Kim Johnson stated, "We are not backing down. We are standing together to tell Congressman Roskam and leaders in Congress that we will oppose any cuts to Medicaid, Medicare and Social Security".

# Retirees Win Battle to Protect Home Care for Seniors

Governor Rauner continues to attack the state's homecare program, the Community Care Program. CCP provides long term care for 80,000 seniors in their homes in Illinois. In 2017, the Rauner Administration attempted to force non-Medicaid-eligible seniors into an untested, poorly patched-together set of services called the Community Reinvestment Program (CRP). This program would force 36,000 seniors out of CCP and into CRP and would cut nearly 31% of their services.

Working in coalition with Caring Across Generations, SEIU Healthcare, AARP and the Alzheimer's Association, retirees mobilized across Illinois to stop implementation of CRP. IARA members participated in actions and meetings with elected officials. IARA leaders, including President Barbara Franklin, Executive Vice President Homer Spaulding, Board Members Gary Hall and Miller Rodgers, retiree activists Dorothy Asbury, Don Todd and Steven Welch, spoke out against CRP at press events across Illinois.

As a result of retiree mobilization, plans for CRP were abandoned during the state budget resolution process in August. IARA and the care coalition continues to stay vigilant as the Rauner administration continues to seek ways to cut CCP. Stay tuned for updates on the fight to protect care for all.
