Tell the Senate: "Pass Build Back Better for Seniors!"

On November 19th, 2021, the House voted 220-213 to pass the Build Back Better Act, H.R. 5376, sending President Biden's sweeping plan to invest in middle class families and expand long-awaited social programs to the U.S. Senate.

The much anticipated bill lingered in the Senate before Senator Joe Manchin (D-WV) stated in an interview on Sunday, December 19th, exactly one month after it passed the House, that he would vote down the Build Back Better Act. With 50 Republican Senators already committed to vote it down, Senator Manchin's vote would be the deciding factor in whether or not it passes.

Why does Build Back Better Matter for Seniors?


The bill contains numerous benefits for older Americans, including: .

- \$150 billion to expand home health care services for seniors and people with disabilities, along with increased wages and benefits for caregiving workers.
- Lower prescription drug prices for all Americans by allowing Medicare to negotiate lower prices for some medicines.
- A \$35 per-month limit on the cost of insulin under Medicare and a cap on outof-pocket prescription drug costs at \$2,000 per year;
- Guaranteed hearing benefits for Medicare beneficiaries, including coverage for new hearing aids every five years.
- Medicare coverage of all vaccines recommended by the Advisory Committee on Immunization Practices (ACIP) — such as shingles, which would be covered at no cost.
- Extended Affordable Care Act subsidies, which would be especially helpful to older Americans who are not yet eligible for Medicare.

The big pharmaceutical corporations have spent more lobbying this year than any other year in history, joining an army of big money interests that are dumping hundreds of millions of dollars into Congress to kill Build Back Better.

Mobilizing the Senior Vote in '22

Retirees across the state are ready to move their power to mobilize Illinois voters in the 2022 mid-term elections.

US Senate: With the consequences of a near 50-50 split holding up Build Back Better in the Senate, it goes without saying that Senator Tammy Duckworth's race this year will be an important one for the entire nation.

US House of Representatives: Vacancies, redistricting, & narrow margins in recent elections have created big opportunities & high stakes races throughout Illinois' Congressional districts. Longtime retiree champion, Rep. Cheri Bustos is vacating IL-17, & Rep. Rodney Davis is vacating his former IL-13 to run in the newly drawn IL-15. Rep. Lauren Underwood has a race many are watching in the IL-14 as she won her last election by just over 1%. These open seats & narrow margins could create the opening to press candidates to elevate the issues that matter most to Seniors.

Statewide Offices: Governor, Attorney General, Secretary of State, Treasurer, Comptroller will also be on the ballot this year. Gov. JB Pritzker will have his bold, progressive agenda tested by the ballot for the first time. After 2 decades of service, Secretary of State Jesse White is vacating his seat, creating an opening in an office that currently prioritizes accessibility for Illinois Seniors.

IL General Assembly: At the time this is being written, the proposed redistricting of the state legislative maps are being disputed in the courts. Regardless of the court outcome, new districts will mean new dynamics in the coming election.

IL Supreme Court: There are 4 seats up for election on the Illinois Supreme Court. This is particularly important to retirees as it relates to the continuation of the Pension Protection Clause of the Illinois State Constitution, among other issues.

Workers' Rights Amendment: This amendment to the Illinois State Constitution will grant workers the fundamental right to organize and to bargain collectively through a union. It will prohibit any law from passing that would interfere, negate, or diminish the right of workers to organize & collectively bargain for better wages, hours, and other conditions.
