## **President's Letter**

## Dear Illinois Alliance Members:

This year 2023 has been a challenging year for the IARA. Our legislative work this year was quieter than usual, but many of our affiliates met with their members of congress such as Sean Casten, Lauren Underwood and Nikki Budzinski to ask them to sign on as sponsors of the Social Security Act. Everyone signed on. The Social Security Act not only strengthened our benefits, it also would eliminate the WEB/GPO which adversely affects retired teachers and other retirees who worked in the public sector.

We did play a major role in getting HB3957 passed and signed into law by the Governor. HB 3957 creates the Pharmaceutical and Health Accountability, it places restrictions on manufacturers' amoral behavior through reasonable oversight. Which gives the Illinois Attorney General the right to investigate suspected price gouging by pharmaceutical companies. This bill is an important first step in bringing the cost of medications under control. We began working on the bill in 2018 when we surveyed us members and learned that many members couldn't afford their medications and were forced to choose between buying their medications or buying food.

In September the IARA held its biannual convention at the Pat Greathouse Center in Ottawa Illinois. Members of the IARA came together from across Illinois to plan our course over the next two years and to elect our new Board and our President and Secretary. Don Todd was elected President and Jane Russell Secretary.

In October due to challenging financial hurdles, we transitioned our Senior Power Lunch to a virtual format. We presented awards to Chicago Mayor Brandon Johnson, IFT President Dan Montgomery and to our own Vice President Miller Rogers from the UAW.
