### **Our Spring Legislative Priorities**

The Illinois Alliance for Retired Americans has two main focus areas for Spring 2025:

- 1. Tier 2 Pension Reform
- 2. Lowering the Cost of Prescription Medication

At our January Executive Board Meeting, the Illinois Alliance officially Endorsed HB5909/SB3988 which would undo the unjust Tier 2 pensions and create a more equitable system that is supported by labor and retirees.

We also voted to continue our work and support on the Prescription Drug Affordability Board.

> The need to pass this bill is urgent, especially as costs continue to climb across the board. I've said it before, and I'll keep saying it: no one should have to choose between paying for their mortgage, utilities, or groceries and affording lifesaving medication. This issue hits our most vulnerable communities the hardest, particularly seniors on fixed incomes, who are already facing financial strain.



## BUILDING A SENIOR POWERED MOVEMENT IN ILLINOIS

The population of senior citizens in Illinois is going to boom in the next 5 years. The Illinois Department of Aging estimates that by the year 2030, nearly threequarters of a million people will be seniors and this demographic will be 25% of the population.

Social Security, Medicare, and Medicaid are at risk on the Federal level. Future retirees with public pensions who are on tier 2 are going to struggle to retire with dignity and financial security, and every day more and more people struggle to afford their prescription medication.

Over the year, the Illinois Alliance has advocated for legislation that has won bipartisan support including H.R. 82 the Repeal WEP/GPO Act. Alliance leaders were at the forefront of the national task force and built the case for the campaign to repeal WEP/GPO by collecting and sharing stories from people affected, meeting with legislators, writing letters to the editor and op eds, and creating a Facebook group for workers being unfairly denied the benefits they paid for.

The next few years are going to be tough. We will be combatting cuts while holding our champions' feet to the fire to protect the vital programs seniors and retirees depend on. However, we all understand that we are all in this together.

Collectively, we can champion worker rights, mobilize retirees and seniors around the issues that matter to us most, hold our elected officials accountable when they vote against our interest, and raise them up and celebrate when they have our backs.

The Illinois Alliance is the perfect organization to capture the momentum the boost in the senior population is sure to bring, but we need your help. It is time to activate! We need volunteers who are willing to share a story, phone bank, meet with legislators, write letters to the editor, attend lobby days, and much more. Let us know how you would like to be involved this year in building a senior-powered movement in Illinois.
